Your request will be reviewed within 30 days once ALL required documentation is received.

<p>Loss of Income <input type="checkbox"/></p>	<p>Family has experienced an involuntary loss of employment or substantial reduction of income.</p> <p><i>Required Documentation:</i></p> <ul style="list-style-type: none"> • Written statement indicating the person who was affected and explaining the cause, date occurred and expected duration • Signed 2023 Federal Income Tax Return including any schedules and W-2s
<p>Medical or Dental Expenses <input type="checkbox"/></p>	<p>Family has excessive medical or dental expenses that were not covered by insurance or health savings accounts.</p> <p><i>Required Documentation:</i></p> <ul style="list-style-type: none"> • Copy of Receipts showing payment for medical/ dental expenses or, • Copy of 1040 Schedule A showing medical costs
<p>Private Tuition Paid <input type="checkbox"/></p>	<p>Family has paid more than \$2500 for private elementary or high school tuition for younger sibling(s) of the applicant during the 2023 calendar year.</p> <p><i>Required Documentation:</i></p> <ul style="list-style-type: none"> • Financial Statement or letter from the school which includes the school's name, the name of the student(s) and the exact amount paid for tuition during 2023
<p>One-time Increase in Income <input type="checkbox"/></p>	<p>Family received a one-time increase in income due to a unique circumstance (e.g. inheritance, early withdrawal from retirement account, income from sale of property, etc.).</p> <p><i>Required Documentation:</i></p> <ul style="list-style-type: none"> • Written statement explaining the situation and any supporting documents

Legal Separation or Divorce <input type="checkbox"/>	<i>Required Documentation:</i> <ul style="list-style-type: none"> • Copy of court order, divorce decree or legal separation
Death of Parent or Spouse <input type="checkbox"/>	<i>Required Documentation:</i> <ul style="list-style-type: none"> • Copy of Death Certificate or Obituary • Documentation of any death benefits received
Other Special Circumstances <input type="checkbox"/>	<i>Required Documentation:</i> <ul style="list-style-type: none"> • Signed and dated letter explaining the circumstances along with any additional documentation you would like to have considered
Unusual Circumstance <input type="checkbox"/> Dependency Override: A student who is unable to contact a parent or where contact with a parent poses a risk to the student may qualify for a change to their dependency status <i>*If approved by FTC, this will carryover to future award years provided circumstances remain unchanged</i>	Examples of an Unusual Circumstances include: <ul style="list-style-type: none"> • Human trafficking • Abusive family situation, which has created an extreme hardship and may prevent the student from attending college • Victim of a documented child abuse case • Student is a ward of the court or is in the custody of DHS • Student is completely abandoned by the parents from all emotional, financial and physical support • Parental incarceration <i>Examples of Supporting Documentation may include:</i> <ul style="list-style-type: none"> • a documented interview between the student and the financial aid administrator; • a documented phone call or written statement, which confirms the unusual circumstances with: <ul style="list-style-type: none"> ○ a state, county, or Tribal welfare agency; ○ an independent living case worker who supports current and former foster youth with the transition to adulthood; or ○ a public or private agency, facility, or program servicing the victims of abuse, neglect, assault, or violence; • a documented phone call or written statement from an attorney, guardian ad litem, or court-appointed special advocate that confirms the circumstances; • a documented phone call or written statement from a representative at an institution of higher education that confirms the circumstances; • utility bills, health insurance, or other documents that demonstrate a separation from parents or legal guardians; or • submission of official documentation that the student's parents or legal guardian are incarcerated.
